1 Your affiant, Detective De Shon Andrews, Serial No. 33208, has been a Police Officer for
2 the Los Angeles Police Department for the past twelve years. In January of 2003, your affiant
3 promoted to the rank of Detective. Since this promotion your affiant has worked various assignments
4 which include Autos, Homicide, Robbery, the Abused Child Unit and Force Investigation Division. Your
5 affiant is currently assigned as to Major Assault Crimes, Wilshire Division. While working these
6 assignments your affiant was responsible for investigating and assisting with the investigations of crimes
7 that range from simple battery, murder/manslaughter and the use of force pertaining to police officers. In
8 addition your affiant has attended the Los Angeles Police Departments Basic Detective School, the
9 Robert Presley Institute of Criminal Investigation Courses in Auto Theft and Major Assault Crimes,
10 the Los Angeles Police Department's Homicide Investigators School and the California Robbery
11 Investigators training seminar.

12
13 Christopher Brown and Robyn F. have been involved in a dating relationship for approximately
14 one and a half years. On Sunday February 8, 2009 at 0025 hours, Brown was driving a vehicle with
15 Robyn F. as the front passenger on an unknown street in Los Angeles. Robyn F. picked up Brown's
16 cellular telephone and observed a three page text message from a woman who Brown had a previous
17 sexual relationship with. A verbal argument ensued and Brown pulled the vehicle over on an unknown
18 street, reached over Robyn F. with his right hand, opened the car door and attempted to force her out.
19 Brown was unable to force Robyn F. out of the vehicle because she was wearing a seat belt. When he
20 could not force her to exit, he took his right hand and shoved her head against the passenger window of
21 the vehicle causing an approximate one inch raised circular contusion. Robyn F. turned to face Brown
22 and he punched her in the left eye with his right hand. He then drove away in the vehicle and continued
23 to punch her in the face with his right hand while steering the vehicle with his left hand. The assault
24 caused Robyn F's. mouth to fill with blood and blood to splatter all over her clothing and the interior of
25 the vehicle.

1 Brown looked at Robyn F. and stated, *"I'm going to beat the shit out of you when we get home! You*
2 *wait and see!"* Robyn F. picked up her cellular telephone and called her personal assistant, Jennifer
3 Rosales at (818) 523-5767. Rosales did not answer the telephone but while her voicemail greeting was
4 playing, Robyn F. pretended to talk to her and stated, *"I'm on my way home. Make sure the cops are*
5 *there when I get there."* (This statement was made while the greeting was playing and was not captured
6 as a message). After Robyn F. faked the call, Brown looked at her and stated, *"You just did the*
7 *stupidest thing ever! Now I'm really going to kill you!"* Brown resumed punching Robyn F. and she
8 interlocked her fingers behind her head and brought her elbows forward to protect her face. She then
9 bent over at the waist, placing her elbows and face near her lap in attempt to protect her face and head
10 from the barrage of punches being levied upon her by Brown. Brown continued to punch Robyn F. on
11 her left arm and hand causing her to suffer a contusion on her left triceps that was approximately two
12 inches in diameter and numerous contusions on her left hand. Robyn F. then attempted to send a text
13 message to her other personal assistant, Melissa Ford. Brown snatched the cellular telephone out of her
14 hand and threw it out of the window onto an unknown street.

15
16 Brown continued driving and Robyn F. observed his cellular telephone sitting in his lap. She picked up
17 the cellular telephone with her left hand and before she could make a call he placed her in a head lock
18 with his right hand and continued to drive the vehicle with his left hand. Brown pulled Robyn F. close to
19 him and bit her on her left ear. She was able to feel the vehicle swerving from right to left as Brown sped
20 away. He stopped the vehicle in front of 333 North June Street and Robyn F. turned off the car, removed
21 the key from the ignition and sat on it. Brown did not know what she did with the key and began
22 punching her in the face and arms. He then placed her in a head lock positioning the front of her throat
23 between his bicep and forearm. Brown began applying pressure to Robyn F's. left and right carotid
24 arteries causing her to be unable to breathe and she began to lose consciousness. She reached up with her
25 left hand and began attempting to gouge his eyes in an attempt to free herself. Brown bit her left ring and
26 middle fingers and then released her. While Brown continued to punch her, she turned around a placed

1 her back against the passenger door. She brought her knees to her chest, placed her feet against Brown's
2 body and began pushing him away. Brown continued to punch her on the legs and feet causing several
3 contusions. Robyn F. began screaming for help and Brown exited the vehicle and walked away. A
4 resident in the neighborhood heard Robyn F.'s plea for help and called 911, causing a police response.
5 An investigation was conducted and Robyn F. was issued a Domestic Violence Emergency Protective
6 Order (EPO).

7
8 Your affiant conducted an interview with witness Melissa Ford who advised that on February 8, 2009 at
9 approximately 0055 hours, she received a telephone call from Robyn F. from an unknown telephone
10 number, later identified as the cellular telephone of Police Officer III Chavez, Serial No. 32483. Robyn
11 F. advised Ford that she had been assaulted by Brown. At approximately 0100 hours, Brown called
12 Ford as if nothing had happened. Ford advised Brown that she had already talked to Robyn F. and was
13 aware of what happened. Ford advised Brown that the neighbors had called the police and that they were
14 with Robyn F. Brown asked Ford if Robyn F. had provided the police with his name and Ford advised
15 him that she had. Brown hung up the cellular telephone and did not call back.

16
17 On February 8, 2009 at 1900 hours, Brown surrendered himself to your affiant and was arrested for 422
18 PC, Criminal Threats. Brown was given a copy of the EPO and advised not to contact Robyn F.

19
20 On February 17, 2009, Ford advised your affiant that she had received text messages from telephone
21 number (804) 929-1743, a number that Ford recognizes as belonging to Brown. In the text message,
22 Brown apologized for what he had done to Robyn F. and advised Ford that he was going to get help.

SEARCH WARRANT AND AFFIDAVIT

1 Your affiant is requesting the telephone records and text message data stored on the cellular telephones of
2 Robyn F., (914) 316-1889, Ford, (914) 320-9045 and Brown, (804) 929-1743, in an attempt to establish a
3 time line of the events that occurred on the evening of February 8, 2008 and to further implicate Brown
4 as the person who assaulted Robyn F.
