I was dispatched to a report of an adult male who had fallen and was bleeding from his head. The complainant was his wife. It was reported that patient was semiconscious. The first officer on scene stated the bleeding from an estimated 2 inch laceration was controlled.

Upon my arrival, I found the patient being assisted in sitting on his buttocks with his legs stretched out in front of him. The officer had a dressing applied to the back of his head. There was what appeared to be about 1/2 cup of blood pooled on the tile floor where he sat with some smearing from the patients own movement. He was wearing only

He seemed slightly disoriented, but was able to answer questions from rescue workers.

The complainant was communicating from the upstairs balcony, she told workers she could not see any blood or she would pass out or go into a seizure. Her behavior was typical of other medical calls I have responded to at this residence.

The complainant stated she was upstairs in the master bedroom when she heard a thud. She thought the patient had dropped something and called down to him. She did not get a response and rushed down to find him unconscious laying on the floor. She immediately called for emergency assistance.

I observed nothing suspicious. Gary had a treatment about two hours earlier. I have been on two other calls where the same patient had In the few minutes officers were with the patient he became more and more lucid. The patient was assisted in walking to the ambulance by rescue workers then transported to the hospital.

SUPPLEMENTAL NARRATIVE :**Name:** Johnson K**Date:** 11:22:35 06/01/10

Officers responded to a medical call involving an adult male who had fallen and hit his head. It was reported while en route that the patient was unconscious and breathing was unknown.

I arrived first on-scene and entered the residence through the garage door on the East side of the residence. The complainant Ms. Shannon Price was at the door and directed me to where the patient Mr. Gary Coleman was located. Ms. Price then went upstairs and spoke over the hand rail as to avoid having to see the blood on the floor.

I entered the kitchen area and found Mr. Coleman sitting back on his legs with his arms in front of him and hands on the floor. Mr. Coleman had a towel over the back of his head and was wearing There was a second towel on the floor near his hands. Also on the floor was a small pool of blood with little smearing next to it.

I made contact with Mr. Coleman by calling him by name and advising him that I was a police officer and that we were there to assist him until medical personnel arrived. I asked Mr. Coleman if he could tell me what had happened. He looked at me and stated that he could not remember. I asked if he hit his head on the floor or the kitchen counter or where and he again told me he did not remember.

I removed the towel from Mr. Coleman's head and observed a laceration to the back of his head approximately 1 to 1.25 inches long. The bleeding had stopped; however, I applied clean sterile gauze patches and pressure to the wound until medical personnel arrived to take over patient care.

While waiting for medical personnel I could tell that Mr. Coleman was weak. He would act like he was about to pass out. I would then call his name firmly and he would then perk up some and make eye contact with me and say "what?". Mr. Coleman could not tell me what had happened or how he hit his head. After medical personnel wrapped the wound I assisted with walking Mr. Coleman out of the kitchen and into the garage where a gurney had been pre-positioned. Coleman was able to walk out and into the garage with some assistance.

While waiting for medical personnel to arrive, and again after they left for patient transport, I looked around the kitchen area for any areas of possible impact besides the tile floor. I could not locate any other blood in the kitchen area or other objects where Mr. Coleman may have otherwise fallen and hit his head. There was nothing of suspicion to note in the kitchen area of the home.

After looking over kitchen Officer Spika and I went upstairs to speak with Ms. Price. She was lying in her bed and asking about Mr. Coleman's condition. She advised that he had just had earlier that morning and she thought

The two had been in the bed watching television when she asked Coleman if he would go downstairs and prepare her some food. He agreed and went downstairs. A short time later Price heard a loud thud as if Coleman had dropped something heavy or as if he may have fallen himself. Price went to check on Coleman when he did not respond to her calls and found him laying on the kitchen floor with blood around his head. She then called 911 for medical assistance.
