b. Who was there? myself, Ronald Modica, Avery Modica

c. What did the person in 2 do or say to you that made you afraid? I was doing Ronald a favor and taking Avery on Sunday. He told me I had to come get him. I took Ronald and Avery to his business to drop Ronald off. He took my phone and keys out of the ignition while my car was in the middle of traffic. He was yelling at me calling me nasty names in front of Avery. Threatening me that he was "done" and I'm fucking dead. Meanwhile, our son Avery was yelling "daddy stop, your hurting mommy... get out of mommy's car." He continued yelling an inch from my face that I'm dead. after about 10 minutes he gave my keys and phone back and I drove off.
