GET A DRINK. VOI FOLLOWED NGR GIRLFRIEND TO THE BAR WHEN SHE STATED SHE TOOK NOTICE OF SOI (RODMAN) AND "PERKED UP". VOI [REDACTED] STATED RODMAN WAS WALKING TOWARD NGR WAY, WHEN HE STOPPED NEXT TO HER, LEANED OVER TO VOI [REDACTED] WHISPERED SOMETHING IN HER EAR, AND THEN PROCEEDED TO PLACE HIS HANDS BET- WGEN HER LEGS AND GRABBED HER CROTCH AREA. IMMEDIATELY RIGHT AFTER, VOI [REDACTED] SAID SHE LOOKED FOR SECURITY AND NOTIFIED THEM OF THE INCIDENT THAT HAD JUST HAPPENED. VOI [REDACTED] NOTIFIED SOI (MR. DAVIS) AND SECURITY, WHO THEN TOOK VOI [REDACTED] TO THE SECURITY OFFICE. WYBE OFFICERS MET WITH NGR. VOI STATED THERE WERE NO WITNESSES TO THE OCCURRENCE. VIDEO SURVEILLANCE AVAILABLE AND IMPOUNDED IN PED DEPT SHOWS CONTACT BETWEEN VOI AND VOI [REDACTED]. CRIME SCENE PALACIOS () REG- POUNDED FOR PHOTOS OF VOI [REDACTED]. SGT. ROJO (#325) AND SGT. AGUILAR ON SCENE. VOI ALSO WROTE A VOLUNTARY STATE- MENT SUBMITTED WITH THIS REPORT.

DEC. ALBA AND SGT. HARRI (887) SPOKE TO SOI (RODMAN) AND SOI STATED HE HAD NOT TOUCHED VOI INAPPROPRIATELY AND TO HAVE VIDEO PULLED. SOI WAS IN THE COMPANY OF MR. (BRIGHT) (MR. RODMAN'S ASSISTANT), MR. PALUMBO (MR. RODMAN'S BODYGUARD), AND MRS. WARNER (MR. RODMAN'S GIRLFRIEND).
