NARRATIVE The undersigned has probable cause to believe the above-named defendant, on the 05th day of MARCH 2005, at approximately 0100-0200 a.m. p.m. at FLORIDA HOSPITAL ER GOLE, ROLLINS AV. ORLANDO FL (Zone: C-4) in Orange County did:

ETHELIZATION WAS EXPLAINED TO THE A BY THIS AFFIANT WHILE THE A ALONG WITH WJ (OFF. KVTMA) WERE IN THE BATHROOM AT APPROX. 0030 HRS (03-04). THE A STATED TO ME THAT HE HAD UNDERGONE THAT PROCEDURE BEFORE. THE A FAILED TO PROVIDE A URINE SAMPLE AT THAT TIME AT APPROX. 0100 HRS THE A WAS MOVED FROM THE HALL TO THE CONF ROOM. THE A WAS HANDCUFFED TO A GURNIEY (LEFT HAND TO THE POP UP RAIL). THE A WAS TOLD AGAIN THAT HE NEEDED TO PROVIDE A URINE SAMPLE BY WITNESSES 1 & 2. THE A WAS GIVEN A PORTABLE URINAL AND APPROX. 20 MORE MINUTES TO PROVIDE A SAMPLE, HE DID NOT. WHEN THE A REALIZED THAT THE NURSES WERE GUARDED UP & READY TO DO HIM THE A LOWERED THE RAIL AND GOT OFF THE GURNIEY. I ORDERED THE A BACK ONTO THE GURNIEY WITH TASER DRAWN HE COMPLIED. WE SET AN OPEN CATHETER KIT ON THE GURNIEY WITH THE A THE A GRABBED IT & THREW IT ON THE FLOOR. A WAS REPEATEDLY TOLD TO COOPERATE. WITNESSES 1 & 2 APPLIED LEATHER RESTRAINTS WHILE THIS OFFICER KNOTTED ON TOP OF THE A WITH MY LEFT KNEE ACROSS HIS CHEST & RIGHT KNEE ACROSS HIS HIPS. I SUPPORTED MY UPPER BODY WEIGHT BY HOLDING THE RSD RAIL. AFTER THE A WAS RESTRAINED I GOT OFF HIM AND HE STARTED THRASHING VIOLENTLY. WITNESSES 1 & 2 TRIED TO RESTRAIN A WITH MINIMAL EFFECT. THE A RESISTED BY SPREADING HIS THIGHS & PULLING ON HIS PANTS WITH HIS LEFT HAND TO PREVENT THE NURSE TECH (W2) FROM ACCESSING HIS PENIS. THE A THRASHED HIS TORSO AS I TRIED TO RESTRAIN HIS RT. SHOULDER. THE A THRASHED & GRABBED HIS PENIS WITH HIS LEFT HAND & REFUSED TO LET GO. I HAD MY TASER (WITHOUT CARTRIDGE) TO THE A'S INTERIOR UPPER FOREARM AND GAVE REPEATED VERBAL COMMANDS FOR HIM TO STOP RESISTING, LET GO OF HIS PENIS & LIE STILL. THE A CONTINUED THRASHING. I ADMINISTERED A PAIN (< 0.5 SECOND) CONTACT APPLICATION AND REMOVED THE TASER AS SOON AS THE A RELEASED HIS PENIS. WHICH HE DID READILY. THE A AGAIN GRABBED HIS PENIS TIGHTLY AS THE TUBE CAME CLOSER & THRASHED AGAIN. AFTER MORE VERBAL WARNINGS THE TASER APPLICATION WAS REPEATED AS BEFORE WITH THE SAME EFFECT. AFTER THE SECOND SHOCK THE A STATED HE WOULD UNMUTE AND CALMED DOWN ENOUGH TO BE GIVEN THE PORTABLE URINAL. THIS TIME THE A GAVE A SMALL URINE SAMPLE OF APPROX. 15-20 CC'S. SGT. C. STEWART WAS NOTIFIED & RESPONDED. THE A'S VITALS WERE TAKEN AT APPROX. 0100 HRS & WERE AS FOLLOWS B.P. 130/80 PULSE 74 TEMP 98.6. THE A HAD NO VISIBLE INJURY FROM THE TASER AND VERBALIZED NO MEDICAL COMPLAINTS FROM THE TASER APPLICATION. AFTER THE LEATHER RESTRAINTS WERE APPLIED THE A ADMITTED TO THIS REFUSED THAT HE LIED EARLIER. WHICH HE CLAIMED TO HAVE UNDERGONE THIS CATHETER PROCEDURE BEFORE. ONLY THE MINIMUM FORCE NECESSARY WAS USED TO COMPEL THE A TO RELEASE HIS PENIS. THIS ATTEMPT WAS DEEMED MEDICALLY NECESSARY.
