The undersigned is informed and believes that:

COUNT 1

On or about February 23, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by AUDRINA PATRIDGE, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 2

On or about August 23, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO and DIANA TAMAYO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by LINDSAY LOHAN, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 3

On or about December 19, 2008, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO, ROY LOPEZ, JR and COURTNEY LEIGH AMES, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by PARIS HILTON, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 4

On or about May 9, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by RACHEL BILSON, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 5

On or about July 1, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by DIANA TAMAYO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by ASHLEY TISDALE, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 6

On or about July 15, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO and ALEXIS CHRISTINE NEIRS, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by ORLANDO BLOOM, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 7

On or about October 1, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by BRIAN AUSTIN GREEN, MEGAN FOX, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)." It is further alleged that the above offense is a violation of Penal Code Section 462(a).

COUNT 8

On or about October 11, 2009, in the County of Los Angeles, the crime of FIRST DEGREE RESIDENTIAL BURGLARY, in violation of PENAL CODE SECTION 459, a Felony, was committed by NICHOLAS FRANK PRUGO, who did enter an inhabited dwelling house and trailer coach and inhabited portion of a building occupied by NICK DELEO, with the intent to commit larceny and any felony.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)." It is further alleged that the above offense is a violation of Penal Code Section 462(a).

NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.

NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and Cunningham v. California 2007 U.S. LEXIS 1324.
