This shall serve as notice pursuant to California Rules of Court, Rule 3.1200 *et seq.*, that on Monday, **June 6, 2011**, at 8:30 a.m. in Department 86 of the Los Angeles Superior Court, located at 111 N. Hill Street, Los Angeles, California, Defendant Jennifer Lopez will apply *ex parte* for an order clarifying the Court's May 26, 2011 Order granting Plaintiff Claudia Vazquez's Motion for a Preliminary Injunction. We will seek an order clarifying the scope of the Preliminary Injunction to be issued and that the Court's Order does not authorize Plaintiff to sell, license, distribute or disclose the Home Video Materials depicting Jennifer Lopez, which are the subject of the action titled *Jennifer Lopez v. Ojani Noa, Ed Meyer, et al.*, Los Angeles Superior Court Case No. BC 425565 ("Lopez II"), and which Ojani Noa, Ed Meyer and any persons aiding, abetting, assisting or acting in concert with Noa or Meyer are prohibited from selling, distributing or disclosing pursuant to the Preliminary Injunction issued in Lopez II on December 1, 2009.
