1 DISCUSSED, THE COURT SHOULD NOTE THAT THE DEFENDANT TAKES THE  
2 FOLLOWING PERScription DRUGS: NEXIUM, ZOLOFT, TRAZADONE, ADDERALL,  
3 AND SOMETIMES DILAIIDID FOR DENTAL PAIN.  
4 THE DEFENDANT WAS TESTED FOR DRUGS AND ALCOHOL ON MAY 27, 2010, AND  
5 THE TEST WAS POSITIVE FOR AMPHETAMINES. THIS IS NOT A VIOLATION OF  
6 PROBATION AS THE TEST RESULT IS POSITIVE BECAUSE OF THE DRUG  
7 ADDERALL. THE NEXT TWO TESTS ON JUNE 2, 2010, AND JUNE 7, 2010, WERE  
8 POSITIVE FOR AMPHETAMINES AND OPIATES. THIS IS NOT A VIOLATION OF  
9 PROBATION, AS THESE TESTS WERE POSITIVE FOR ADDERALL AND THE PAIN  
10 MEDICATION DILAIIDID. THE TEST RESULTS FROM JUNE 16, 2010, AND JUNE  
11 24, 2010, WERE POSITIVE FOR AMPHETAMINES. ONCE AGAIN THERE IS NO  
12 PROBATION VIOLATION AS THE POSITIVE RESULT IS A RESULT OF THE DRUG  
13 ADDERALL. AT THE TIME OF THIS WRITING, THE TEST RESULTS FROM JUNE  
14 30, 2010, ARE UNKNOWN.  
15 THE DEFENDANT HAS REPORTED FOR SUPERVISION AS INSTRUCTED, AND HER  
16 ATTITUDE HAS BEEN POSITIVE. SHE HAS BEEN COOPERATIVE WITH PROBATION  
17 OFFICER, AS SHE HAS PROVIDED MEDICAL PROOF FOR HER PERScription  
18 DRUGS, AND SUBMITTED TO DRUG TESTS WHEN REQUESTED.

19 **DEFENDANTS STATEMENT:**

20 THE DEFENDANT INDICATES SHE HAS BEEN ON THE SAME PERScription  
21 MEDICATION FOR AS LONG AS SHE CAN REMEMBER. SHE STATES SHE WANTS TO  
22 MOVE ON WITH HER LIFE, AND FEELS THAT SHE HAS DONE EVERYTHING THAT  
23 THE COURT HAS ASKED HER TO DO.

1 **REMARKS:**

2 SINCE THE LAST HEARING ON MAY 24, 2010, THE DEFENDANT HAS REPORTED TO  
3 THE PROBATION DEPARTMENT SIX TIMES. SHE HAS SUBMITTED TO DRUG AND  
4 ALCOHOL TESTS, AND THE TESTS HAVE NOT BEEN POSITIVE FOR ALCOHOL OR  
5 ANY ILLEGAL SUBSTANCES.

6 IT IS RECOMMENDED THAT THE DEFENDANT BE CONTINUED ON A SUMMARY GRANT  
7 OF PROBATION.
