On the above date I was traveling E/B on Kennedy Blvd, near Dale Mabry Hwy. At this time I noticed the defendant traveling W/B on Kennedy Blvd. I noticed the defendant because her right front head light was not working. At this time I turned around on the defendant in order to conduct the traffic stop for the traffic violation.

When I activated my lights the defendant pulled into the parking lot at the Westshore Mall. At this time I approached the drivers side window. I came into contact with the defendant. I asked the defendant for her drivers license and registration. During this time I advised the defendant of the reason that I stopped her. As the defendant was looking for her information she asked me again why I stopped her. During this time I could smell a distinct odor of an alcoholic beverage coming from the vehicle. The defendants eyes were bloodshot, watery and glassy. The defendant made inconsistent responses when I asked her about drinking. At this time I asked the defendant to exit her vehicle. As she exited I noticed that she had to use the vehicles door for support. When the defendant stood still she would sway side to side. After seeing these cues of impairment I asked the defendant to perform the field sobriety exercises. The first exercise I asked the defendant to perform was HGN. The defendant exhibited a lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation, and she had a 335 degree angle of on-set on nystagmus.
