1 **DETAILS:**

3 On Monday 05/02/11, at 2107 hours, I was dispatched to the Marie Callender's Restaurant, located at 29363
4 Rancho California Road, in the City of Temecula, reference a 647(f) PC-Public Intoxication. The subject
5 arrived to the location intoxicated and was belligerent with restaurant employees. Upon my arrival I met
6 with an employee of the restaurant, who wished to remain anonymous, and she told me the subject, later
7 identified as Andy Dick, had been yelling at the staff, demanded staff serve him alcohol, and threw popcorn
8 on the floor in the bar area of the restaurant.

10 The employee advised me the restaurant had not served Dick any alcoholic beverages and requested Dick be
11 removed from the location. I contacted Dick and escorted him from the restaurant to the parking lot. He
12 displayed symptoms consistent with alcohol intoxication. Dick had a strong odor of an alcoholic beverage
13 emitting from his breath and person. Dick stumbled and needed my assist to walk when I escorted him from
14 the restaurant. Furthermore, Dick's speech was slurred and his eyes were red and watery.

16 Due to Dick's level of intoxication, I determined he was unable to care for himself. I subsequently arrested
17 him for 647(f) PC-Public Intoxication. I transported Dick to the Southwest Detention Center where he was
18 booked for the above listed charge. Dick was arrested for public intoxication only and later released per
19 849(b)(2) of the California Penal Code.
